NOTE: All matters concerning crimes committed by or against students and staff will be assigned to a detective. All non-criminal matters will be reviewed by the Detective Bureau Supervisor and generally assigned to a Juvenile Officer.

Animal Issues: The Borough of Glen Rock contracts with TYCO Animal Control Services for various animal issues. Their direct number is (201)-652-4554. Leave a message on the voicemail, and someone will return your call within the hour.

They handle such issues as sick, injured, or dangerous animals, stray domestic animals, dead animals on public and private*** property, nuisance wildlife, complaints about owned animals, and reporting a lost pet. (***) – A \$60.00 charge will be assessed to pick up dead animals on private property***).

Members of the Glen Rock Police Department are not trained as Animal Control Officers and do not have any special equipment for the handling of domestic or wild animals. If an expedited response from Animal Control is required officers may contact the service directly through Central Dispatch.

BACK TO SCHOOL SAFETY MESSAGE – SEPTEMBER 2018

One of the most critical elements in school safety is getting our community's children to and from school safely. The Glen Rock Police Department assigns School Crossing Guards at twenty key locations to assist children going to and from our schools. While the primary role of a school crossing guard is to guide children safely across the street, each guard plays another key function — a role model helping children develop the skills necessary to cross streets safely at all times. The position of crossing guard is one of the most dangerous of municipal jobs due to uncooperative motorists and accidents.

As staffing and service requirements permit Police Officers are assigned to periodic enforcement details at our schools and in school zones. However, the number of school buildings alone outnumber the Police Officers on patrol any time of the day. ***It is impossible to have an officer at every school and in every school zone each day.*** We therefore rely on the cooperation of parents, students and school staff in providing a safe environment.

The responsibility of parents to provide for safety in our school zones requires the cooperation of each parent to:

1. Leave home early and expect delays, traffic is going to move slowly. The priority in any school zone is the safety of children. If you are running late you are going to be late!
2. Drive slowly and avoid distractions, especially your cell phone.
3. Learn and follow the school's drop off and traffic safety plan. Each school's traffic safety plan relies on **YOUR** cooperation. Contact the school's principal with any questions or concerns.
4. If you need to spend time at your child's school beyond a simple drop off or pick up, you must find a legal parking space. ***Be prepared to walk***, parking directly near your child's school will seldom be possible.
5. Always stop when directed to do so by a School Crossing Guard or Police Officer.
6. Do not block crosswalks, intersections, fire zones, park illegally or block the neighboring resident's driveways.
7. Avoid making U-turns or backing up within the school zone markings.
8. If you park on the side of the road, always have your child exit the car on the side away from traffic.
9. Don't park so that your child dashes across the street to get to the school.
10. Always have your child use the designated crosswalk, this includes when you are walking with them. You set the best example for your child!
11. Remind your child to follow the school crossing guard's instructions.
12. If you have a child who is recovering from an injury, has some form of restricted mobility or there is an emergency please contact the Glen Rock Police Department ***in advance*** for assistance. School Principals ***do not*** have the authority to grant special parking permission on Borough Streets, in Fire Zones or to permit parking in Handicapped Zones without a State issued permit. **Once a parking summons has been issued it cannot be taken back.**
